#### 1.0 Bipartisan Infrastructure Law (BIL)

- The FAA has agreed to accept the application for the fence relocation.
- Draft work order is available for review. We will ask for approval in January.
- The FAA has confirmed the project's eligibility and agreed to proceed with utilizing FY 22 & 23 Bill funds with a total of \$244,444 (Fed \$220,000, State \$12,222, Local \$12,222).

#### 2.0 AIP 24 - Runway 9-27 LED Lighting - Construction

Project is now closed out.

#### 3.0 Parking Lot Project

 The warrantee claim on a spot where some solvent was spilled on the asphalt mat during paving has not been patched yet. Will need to wait until spring at this point.

#### 4.0 Parallel Taxiway Re-Alignment Project

We will be presenting a draft agreement for the Environmental and 20% Design (Part A) next month with action item to pass in March. This will utilize the FY 2023 NPE funds.
 NPE deadline this year is expect to be the end of April.

#### 5.0 Taxiway and Crack Repair and Painting Quotes

- Quotes are due by the end of the day March 27.
- As of 3/25 we have 2 quotes for crack sealing and 2 quotes for painting.

- 2. Curtsey Car Used cars are inflated right now do to the tax season, I would like to wait 60 more days to give the market a chance to go back down.
- 3. Airport Security Contractor ran the Cat 5 Cable will be back to install the cameras and new system equipment.
- 4. T-Hangar Lighting All lights installed; contractor is completed.
- 5. Main Hangar Heat Heat installed works great; contractor is completed
- 6. NIPSCO Gas Sent NIPSCO the required information they requested for them to generate a quote.
- 7. Cement Slab for the propane tank to set on for the main hangar. Cement Slap Installed.
