Airport Manager Training. On a motion made by Steve Plank and seconded by Molly Long, the BOARD voted 4-0 to approve the hourly wage rate of \$33.31 for any hours accumulated by Jill Van Horn after October 22, 2020. Mrs. Van Horn will present the BOARD with a weekly schedule of available hours during the transition period between Airport Managers.
