### 1.0 Bipartisan Infrastructure Law (BIL)

## 2.0 AIP Funded Projects

- AIP 24 Runway 9-27 LED Lighting Construction
  - Michiana has been given the NTP. They are waiting on spring weather and parts to begin.
  - Once this work is complete, we will close the grant.

#### 3.0 Miscellaneous

- Parking Lot Project
  - Work has been paused until the site dries out.
  - Chad has helped get Comcast engaged on their vault modifications after 811 failed to mark the location or ID the owner.
  - Consideration of the light pole installation for \$9260.00
  - No progress estimate for payment this month.
- Runway Crack Repair
  - Metro hopes to begin in April. They have been instructed to coordinate with Chad.
  - Weather has been too poor to begin.

### AIRPORT MANAGER'S REPORT

- Dashboard Report Updated, will use the rest of the bond funds for Parking lot project.
- 2. Virtower Report Report under other TAB We are still working out the bugs, example it shows we had two different helicopters come in but, on the summary, it only shows one landing and one taking off. Most likely this was caused by one helicopter using the runway and the other one landing on the ramp.
- 3. Equipment Building Schedule for May Start.
- 4. Podium We needed a podium for events, i.e., Mayors Round Table. Looking at Podiums they ranged from a couple hundred dollars to thousands. I contacted Chris Havrilesko about making

- one. He said he could, and it would be under a \$1000.00, so I had him make us one. He made a beautiful podium out of Tiger Mable.
- 5. Runway resealing Waiting on Contractor to start
- 6. Vault Building Waiting on Contractor to start
- 7. Tim Dalton Debt \$350.00 March 16 Tim Dalton debt, have not received any payments since March 8, board would like the airport manager to follow-up with Indiana State Board of Accounts.
- 8. Bluebird Hangar Heating System Delayed waiting on Dilling Group to give us an estimate. They stated per NFPA 409 Standard on Aircraft Hangars. Section 5.12.5.2 In Aircraft storage and servicing areas, heaters shall be installed at least 3m (10 FT) above the upper surface of wings or of the engine enclosures of the highest aircraft that are capable of being housed in the hangar. The measurement shall be made from the wing or engine enclosure whichever is higher from the floor to the bottom of the heater. Currently the AG aircraft from the engine to the ceiling is 8 feet from the ceiling and the wing is 10 feet from the ceiling. Then the heater hangs down 3 feet from the ceiling. So, the max distance the heater will have is 5 feet from the engine and 7 feet from the wing. Board requested updated quotes with the Radiant tube heater installed on outside walls facing inwards.
- Bonus Motion to give Rose Wagoner a bonus of \$1150.00 per quarter, starting July 2022. The Bonus will be reviewed the beginning of each year. Motion by Bob Barr, Molly Long 2<sup>nd</sup> the motion, Roll Call, Unanimous Vote.
- 10. The hangar outlets have been separated to individual circuits.
- The Airport Firewall and Wireless router has been upgraded, except for the extender for downstairs, it is on back order.
- 12. New Holland Tractor has been serviced for this year and is ready to go.
- 13. John Deer is currently getting it yearly service maintenance at John Deer
- 14. New T-Hangar Electric Doors Have a electrician to give a quote on changing the open and close circuit to be automatic.
