 - The contractors have been slow to respond. Since the work is to be performed in the fall we will give them another month. We will review the quotes received in the August meeting. The FAA paint is backordered, contractor not sure they will get paint this year.

Discussed replacing electrical vault, waiting on Victor on what we can do with it. - Board requesting Airport manager get quotes on installing automatic vent fan for the vault.

- 2nd Floor Repair Floor coating is completed, I am still installing the door transition pieces.

 - Shadow Ridge Roof Cost \$12,660.00, Inside Cost \$19,240.00 Total Cost \$31,900.00
 - Schleppenbach Roof Cost \$10,330.00, Inside Cost \$16,984.00 Total Cost \$27,314.00
 - K. Graber Roof Cost \$14,465.00 no quote on inside.

- 6. Archer Engine Overhaul Three different choices:
 - ➤ New Engine \$50,600.00 New engine has the same two year warranty as the rebuilt engine.
 - ➢ Rebuilt Engine \$28,294.00 Lycoming is the only FAA-authorized manufacturer that can rebuild your Lycoming engine to an absolute zero-time status. We test every rebuilt engine part to new tolerances, so they meet the same requirements as a brand new Lycoming aircraft engine. Rebuilt engines come with a 2-year warranty (O-235 cylinders have a 1-year warranty) including parts and labor honored at any authorized distributor worldwide.
 - Overhauled Engine \$23,895.00 Overhauled engines come with a 1-year parts and labor warranty, and a 2-year warranty on cylinders (except O-235 engine models which have a 1-year factory warranty). Any authorized Lycoming Distributor honors our warranty.

All three choices will have a 13% increase as of 1 Aug 2021.
